



**Consent to use your image, audio or visual recording or testimonials**

**What is this document about?**

1. PICAC Group<sup>1</sup> advertises, promotes and markets the PICAC Group and their commercial and non-commercial activities. This may be done in the form of training materials, newsletters, flyers, publications, audio film collages, other promotional and marketing materials, activities on social media platforms, material on their website, etc. In this document, we will refer to these activities as the **“Specified Purpose”**.
2. PICAC Group would like to use photograph(s), photographic negative(s), audio, testimonials and video image(s) (whether still image or otherwise) of PICAC’s students for the Specified Purpose. The audio, images and videos used can often identify the student involved. Consequently, these recordings are considered personal information. 2. I understand that the PICAC Group may use my Personal Image for the Specified Purpose. I agree and grant the PICAC Group the right to use my Personal Image for the Specified Purpose.
3. I understand that my Personal Image may be used for PICAC Group’s commercial or non-commercial purposes.
4. I understand and grant PICAC Group the right to use and modify the Personal Image and use it as testimonials or create collages.
5. I understand that the PICAC Group may transmit the Personal Image in digital form over the internet and that, while the PICAC Group will exercise all reasonable precautions to secure the Personal Image from unauthorized distribution, my Personal Image may inadvertently be transmitted and distributed by a third party beyond PICAC Group’s reasonable control.
6. I acknowledge that I am not entitled to any remunerations, royalties or other financial compensation for the use of my Personal Image.
7. By signing this document, I release and discharge the PICAC Group, its agents, contractors, officers and employees, from any and all claims and demands arising out of or in connection with the use of my Personal Image for the Specified Purpose, including but not limited to, any and all claims for invasion of privacy, passing-off, defamation, or damages.
