### PICAC CHAIR'S REPORT

EVERY YEAR SINCE PICAC WAS ESTABLISHED, IT HAS ADDED TO AND REFINED ITS PHYSICAL AND INTELLECTUAL TRAINING AND ORGANISATIONAL CAPABILITY.

FY 2018-19 was a year in which PICAC made several major steps forward, significantly progressing the development of two new training centres, one in Victoria and the other in Queensland.

PICAC Narre Warren is an Australian first. It is the nation's first Net Zero Energy training facility. PICAC Narre Warren is the product of collaboration between major industry stakeholders and a determination to ensure the Australian industry has the training capability to keep it at the cutting edge of global innovation in plumbing products, practices, systems and water and energy efficient applications.

A key focus for the year was progressing the new PICAC facility at Beenleigh, in the growth belt between Brisbane and the Gold Coast. With funding support from the Government and the City of Logan and with in-kind product and equipment support from several major industry stakeholders, PICAC Beenleigh began to take shape in 2018-19.

Students and employers in Queensland will now have access to new levels of high quality training and facilities. The establishment and development of a permanent industry-owned training presence in Queensland helps drive up national training standards for our sectors and prevents skills gaps developing across jurisdictions. PICAC Beenleigh delivers opportunity - for young Australians seeking a highskill/high pay sustainable career; for women to enter the industry; for newly arrived migrants seeking to upskill; or for older workers seeking to transition from traditional manufacturing jobs into the energy, water, gas, fire protection, and the emerging hydrogen sectors.

PICAC has taken these giant steps forward whilst maintaining its high volume, high quality, industry leading training delivery across all aspects of plumbing and fire protection. This year, PICAC trained more students in more places than ever before whilst making a strong contribution to policy, regulatory and related training and industry reviews and development initiatives. PICAC also continued its work with stakeholders and Commonwealth government bodies on training package development for the sector.

PICAC facilitated and hosted industry forums, skills competitions and World Plumbing Day activities. It served as a key industry hub and conduit between training developers, students, industry employers, regulators and policy makers. PICAC's participation in the 2018 Plumbing and Fire Industry Awards recognised the outstanding personal outcomes of the training initiatives within our centres and this activity will continue to demonstrate and record the striving for excellence. In 2018-19 the PICAC team undertook extensive preparatory work to ensure the World Plumbing Conference to be hosted by PICAC in September 2019 is a great success.

My thanks and appreciation go to CEO Shayne La Combre and all the PICAC team for their outstanding work in 2018-19 and I look forward to a very positive 2019-20. I also record my appreciation for the support and endeavour of the PICAC stakeholders and their teams in working with us collaboratively to deliver to the Australian plumbing and fire protection industries the world leading training initiative that is PICAC.

### PICAC CHIEF EXECUTIVE OFFICER'S REPORT

IN 2018-19 PICAC CONTINUED TO FACILITATE AND DELIVER VERY HIGH-QUALITY INDUSTRY TRAINING FOR THE PLUMBING AND FIRE PROTECTION INDUSTRY.

PICAC maintained the quality and currency of training delivery whilst undertaking significant development work for new training facilities in Victoria and Queensland. The PICAC team also undertook extensive preparation work to host the World Plumbing Conference in September 2019.

PICAC continued the delivery of training covering the entire career lifecycle, from pre-apprenticeship training through to post trade specialist courses. In 2018-19 PICAC also expanded its training reach into New South Wales (NSW). One of PICAC's partner entities, Fire Industry Training (FiT) was approved by Training Services NSW to deliver funded Certificate III level training in Fire Protection. At June 30 2019, after operating for 18 months in NSW, FiT has 43 apprentices enrolled in Fire Protection Certificate III at PICAC Lidcombe.

It is the uniqueness and currency of the post trade offerings – which are regularly being revised and developed in consultation with industry - that really sets PICAC training apart from the nonspecialist providers and makes a big impact in terms of community safety.

PICAC's medium term strategic goal is the establishment of a national series of networked training centres delivering a nationally consistent curriculum. This year PICAC significantly progressed a core component of that strategy when it finalised the design of a permanent, industry owned and operated plumbing and fire protection training centre at Beenleigh in south east Queensland and completed the major construction phase of the Narre Warren campus.

The Narre Warren facility is a great example of what industry collaboration can achieve. The building itself, Australia's first Net Zero Energy training facility sets a new benchmark for energy efficient design and engineering facilities.

The physical training facility at Narre Warren is unique. Also unique is the partnership between PICAC, the Master Plumbers, the Plumbing and PipeTrades Employees Union and IAPMO and the conceptual model based around vertical industry integration, which underpins it. IAPMO is a world leader in product testing and certification, standards and code development assistance and quality assurance. It is at the forefront of plumbing product development, emerging energy efficient technologies and even new energy sources like hydrogen. PICAC and our industry stakeholders are at the leading edge of industry training. PICAC Narre Warren brings these two drivers of excellence together, linking product innovation, standards development and training delivery together in an integrated and strategic way.

As the Australian industry adjusts to an energy and water constrained future and as new technologies and potential energy sources emerge, the seamless link between international innovation and Australian industry training, provided by PICAC Narre Warren will help future proof the Australian industry and ensure the Australian economy is able to capitalise on water and energy efficiency innovations. I am, along with the Board and staff of PICAC, greatly looking forward to the opening and operation of this new facility next year.

Thank you to the PICAC team and our industry partners, for your support and dedication in FY 2018-19.

### STC CHAIR'S REPORT

FY 2018-19 IS ONE OF THE MOST SIGNIFICANT IN THE HISTORY OF THE STC AND IN THE DEVELOPMENT OF THE PLUMBING AND FIRE PROTECTION INDUSTRY IN QUEENSLAND.

It is the year in which the industry came together in partnership to enable the training side of the industry to take a significant step forward. The new permanent, industry owned premises at Beenleigh will enable the growth and sophistication of training in Queensland and will facilitate the sustainable delivery of consistently high-quality outcomes for students and employers for decades to come.

Every day innovations are being made in energy efficiency, in more water efficient products, and even in new energy sources like hydrogen. Because we are part of industry, we know what industry employers want and need in terms of the skills of the construction sector workforce, and we can and do tailor our training to meet those changing requirements. Adaptability, currency, and quality are the hallmarks of our training offering, and through our new state of the art training facility we will be better placed than ever before to deliver those things on a consistent and high-volume basis.

Ensuring we continued to meet our commitments to our students, and maintained our very high standards, as we planned for the transition to the Beenleigh facility was a core goal for the year. I am very pleased to report that it was achieved, and we are now all set to make a seamless transition to our new industry hub and training complex and begin delivering training early in the upcoming financial year.

My thanks go to Adrian Shackleton and all the team at the STC who worked tirelessly, especially as the end of lease period approached. My thanks also go to our colleagues at PICAC who worked so hard and supported the STC in the transition and development of the new facility.

I am, along with the entire Board, management, training administration and facilities staff of STC, very excited to begin a new chapter in the STC journey from our new home in Beenleigh in 2019-20.

THE PRIMARY STRATEGIC FOCUS FOR STC IN FY 2018-19 HAS BEEN PREPARING FOR THE PHYSICAL TRANSITION OF STAFF, FACILITIES AND STUDENTS FROM THE RENTED FACILITIES AT SALISBURY TO THE NEW INDUSTRY OWNED PREMISES IN BEENLEIGH.

With the lease on the Salisbury facility due to expire early in the upcoming financial year (August 2019), it has been imperative for the College to be ready for the transition. Coordination and collaboration within the small team at STC, and between STC and its various stakeholders, has been key to the success of the planning and preparation phase.

FY 2018-19 was the third year in which STC has operated under the PICAC model, which has significantly strengthened STC's financial and governance capability and set it on a sustainable financial and operational footing. This has allowed the STC and PICAC leadership to plan with confidence and develop what will be the Queensland industry's physical operating and training headquarters for decades to come. With our industry partners and with the support of the Queensland State Government and the City of Logan, we undertook extensive development work in 2018-19 to ensure the new facility at Beenleigh has the capability to train up to 700 apprentices annually.

In FY 2018-19 STC continued its vital industry development role, coordinating and managing industry training funds to deliver subsidised industry training to maintain the skills of the plumbing and fire protection workforce in Queensland. The new facility at Beenleigh will take our industry development role to the next level, helping ensure the Queensland economy has available to it the skilled workforce capable of taking advantage of industry innovations and technical advances.

It is important for the Queensland economy that Queensland tradesbased training keeps pace with the training being delivered elsewhere in Australia. The Beenleigh development will help ensure that no gap emerges between the currency, quality and availability of high-quality industry training in Queensland and that which is provided in other jurisdictions. I am very proud that this year we were able to complete the ambitious series of tasks necessary to transition the College to its new premises whilst maintaining our high standards of delivery. STC maintained the scope of its recently expanded course delivery, delivering more than 20 different training courses. Our team of experienced trainers delivered thousands of hours of high-quality training to hundreds of apprentices while maintaining an above 90 per cent success rate.

The quality of training delivered by the College is reflected in the fact that one of our students, fourth year apprentice plumber Patrick Wright, won the national Apprentice Skills Contest on World Plumbing Day in March this year and will represent Australia in the international competition in Ann Arbor, Michigan in August 2019.

# EXCELLENCE IN SERVICES

PICAC ASPIRES TO AND ACHIEVES EXCELLENCE IN ALL ASPECTS OF THE INDUSTRY INFORMED TRAINING IT DELIVERS AND FACILITATES.

In 2018-19 PICAC researched, consulted with industry, liaised with governments and then proceeded to develop training content, approaches and infrastructure that will serve the training needs of students, employers, and the community today and into the future. As a part of the industry it serves, PICAC has a unique capacity to adjust its training offerings to address emerging or anticipated industry or community need. This attribute is particularly important in the contemporary industry context, which sees new and innovative products, techniques and systems entering the market all the time. As products emerge that are increasingly water and energy efficient - and new energy sources like hydrogen appear- it is crucial that there is a skilled workforce available to take advantage of these emerging technologies which create new opportunities for industry participants.

As well as being a provider and facilitator of world class industry training, PICAC serves as an authoritative point of reference on a range of policy, regulatory and operational aspects of the industry. In 2018-19 PICAC played an important coordination, submission and policy facilitation role with respect to several major State and Commonwealth reviews or inquiries relating to the industry. The regulation review and re-making process in Victoria, the various reviews and inquiries about product regulation and importation, training packages for plumbing and fire protection, are just a few from a range of examples of the policy and regulatory leadership role played by PICAC.





# A SUSTAINABLE RESOURCE BASE

PICAC HAS A MEDIUM-TERM STRATEGY OF MEASURED GROWTH, EXPANDING WHEN IT HAS THE FINANCIAL CAPABILITY TO DO SO AND IN SUCH A WAY AS TO NOT COMPROMISE QUALITY.

Key to the strategy's success is PICAC's corporate, financial and governance structure, one which is effective, robust, and transparent. PICAC's governance arrangements, together with its proven track record of success in terms of both facilities and training delivery, has enabled it to attract strong grant funding from all levels of government. Together with a reliable training revenue base, this has enabled PICAC to be in a sound financial position which in turn allows it to attract further grant funding.

This positive cycle enabled PICAC to plan and develop new facilities this year in Queensland and Victoria, and to establish a strong training presence in fire protection in New South Wales. The newly established presence in New South Wales and beginning the development of a new training centre in Beenleigh in south east Queensland, are two significant steps towards the development of a national network of integrated training facilities, which is a key element of PICAC's industry strategy.

Just as the national network helps integrate and homogenise high quality industry training in a horizontal sense, the Narre Warren facility will help PICAC to be further integrated with the industry vertically. PICAC Narre Warren will bring together, under one roof, the research, standards, testing, product development, training, and employment aspects of the industry. And it will do so in a world leading, Net Zero Energy building, with many of the energy efficient systems utilised on public display.





### Narre Warren, VIC

PICAC Narre Warren is set to open in September 2019 with practical completion having been reached in April 2019 and fit-out now underway. The centre is being purpose-built to deliver the specific skills the Victorian and Australian economies and communities need now and will increasingly need in the future. This new facility is a joint initiative between PICAC, the Master Plumbers, the PPTEU and IAPMO to deliver world class training for the plumbing industry.

Once complete, the PICAC Narre Warren campus will be the first Net Zero Energy education and research facility in Victoria. The building will generate all energy required to support the operation of the building on site through the incorporation of several renewable energy technologies.

Most notably, the building is the first in Australia to utilize building foundation screw piling to source geothermal energy for its own heating and cooling requirements. Using a specialized Commachio drill imported from Italy, 192 13-metre deep energy piles and 28 geothermal bores were drilled to a depth of 100 metres. Together the 220 wells will be used for the Ground Source Heat Pump (GSHP) system, which integrates thermal heat loops within the structural screw piles for geothermal heat exchange. In October 2018, the vertical structure of the building started to emerge with the installation of the structural steel, pre-cast concrete panels, windows, roof and cladding. Once the roof was complete, a solar PV array comprised of 770 panels that will generate up to 275kW of electricity was installed to contribute to the energy needs of the building.

The PICAC Narre Warren facility will house the Registered Training Organisations Master Plumbers, CEPUTEC and PICAC and will be shared with IAPMO R&T Oceana, who will house their new research centre and product testing laboratory at the facility. PICAC's students and the extended plumbing industry will benefit from the arrangement as training needs associated with innovation and evolving technologies can be directly identified as they progress through the IAPMO certification process. This uniquely positions PICAC to proactively address industry training needs early in the life-cycle of new plumbing products and technologies.

PICAC Narre Warren will house:

- World leading facilities in welding and gas fitting
- 100 Seat General Auditorium
- 12 Training Rooms
- Confined Spaces & Roof Access Training
- Administration Offices



### Beenleigh, QLD

The Service Trades College Australia (STC) is being relocated from Salisbury, QLD, to Beenleigh, QLD.

In late February 2019, work commenced on the PICAC Beenleigh training centre project and has progressed steadily since.

The Beenleigh facility is designed to deliver world-class training in the trade sectors of sanitary plumbing, fire protection and mechanical services (air-conditioning). Beenleigh sits in a significant growth corridor between Brisbane and the Gold Coast.

Once operational the facility will be able to accommodate 400 – 500 fire protection and plumbing apprentices, 100 mechanical services or HVAC apprentices and 100 preapprenticeship trainees.

The work completed so far includes demolition of the existing offices/ administration areas, detailed excavation, pouring of all footings/ slab thickenings and the installation of plumbing drainage. There has also been excavation for the training sandpit and the boring of piers for the training tower has commenced.

Upcoming work for the site includes steel fixing and pouring of concrete piers for the training tower, concreting over floor cuts for plumbing drainage services and internal fit out of functional workshop training areas.

PICAC Beenleigh, set to open in September 2019, will offer students the opportunity to utilise state of the art facilities including:

- In ground drainage and trench shoring training sand pit
- Three level training tower simulating three high rise building levels
- Plumbing and Mechanical Services training facilities
- 14 stationed valve room with various valve types for service, test and maintain training
- Purpose built fire protection training bays
- Gaseous fire suppression systems training room
- Functional electronic and diesel pumps installation for maintenance and live testing training
- Functional control indication panels and warning alarm training area
- Advanced welding facilities
- Safety and High Risk Licence training areas for forklift, EWP under/ over 11m, working at heights and on roofs, and boom lift)
- Confined space training



### Lidcombe, NSW

PICAC Lidcombe opened in February 2018 with two classes of first year apprentice sprinkler fitters undertaking the Certificate III in Fire Protection with Fire Industry Training (FiT). In 2019, those students, now in their second year, were joined by a further

three classes of first-year apprentices, bringing the total student body up to 55 students in 2019. PICAC is exploring options to expand and offer plumbing courses alongside fire protection courses in the future.

# EXTENSIVE INDUSTRY PARTNERSHIPS

PICAC is a partnership, which in turn partners with a range of national and international stakeholders to drive quality and excellence in industry training. PICAC is comprised of the key national industry employee and employer bodies, the Plumbing and PipeTrades Employees Union (PPTEU), Master Plumbers and Mechanical Services Association of Australia (Master Plumbers), Master Plumbers Association of Queensland (MPAQ), National Fire Industry Association (NFIA) of Australia, the Air Conditioning and Mechanical Contractors' Association (AMCA) and the United Association (UA).

In PICAC, these entities, which each have their own immediate areas of focus, have a vehicle through which they can speak with a common voice about issues which transcend sectional interests, and impact the industry as a whole. Ensuring the industry, and the economy, has access to a sufficient number of skilled plumbing and fire protection professionals is one such issue, and the key reason industry works together, through PICAC, is to make sure that training is available, is high quality and is always directly relevant to industry.

PICAC provides an engagement point between the Australian Industry and the international plumbing community. PICAC has well established relationships with international organisations including the World Plumbing Council, the United Association, IAPMO, WorldSkills, Institute of Plumbing South Africa, Indian Plumbing Association, Chartered Institute of Plumbing & Heating Engineering (UK) and the World Health Organisation. PICAC combines these international relations with Australian industry connections, including ABCB, Australian Gas Association, Backflow Prevention Association Australia, Water Authorities, Sustainability Victoria, GAMAA, ESV, AHSCA and the Victorian Building Authority, to knowledge share and provide a high level of training.

The affiliation between the PPTEU and the United Association (UA) from the United States and Canada, continues to serve as a key conduit between the Australian Industry and developments in North America, helping advance the industry in all three countries.

In August 2018 plumbing apprentice, Luke Pettenon and sprinkler-fitting apprentice, Ryan Cox travelled to Ann Arbor, Michigan, USA for the UA's annual International Apprentice Skills Contest.

Luke and Ryan were both finalists in the annual World Plumbing Day Apprentice Skills Contest 2018, held at PICAC Brunswick in March and were selected to represent PICAC and Australia following interviews with the selection panel where they both displayed their positive attitudes, community involvement and problemsolving abilities. The UA International Apprentice Skills Contest is a five-day intensive competition which tests a range of industry related skills. Competing were highly-skilled apprentice plumbers, pipefitters, sprinkler fitters, mechanical service technicians and welders from Australia, Canada, Ireland and the United States. Luke and Ryan both performed very well and earned the respect of their international counterparts. They also gained expert knowledge from a range of trainers and professionals from around the world.

PICAC supported Amy Kosterman, from Plumbing Apprenticeships Victoria, to participate in CPC 2018 along with Mick Wiech of the Plumbers Union Queensland. They joined plumbers from South Africa, USA, and Canada to install new basins, pipes, taps, toilets, water tanks, water pumps and hot and cold water. They also installed and connected a new wastewater system.

Both Amy and Mick returned from the experience with a new outlook on the world and found the experience incredibly rewarding.
